

END USER LICENSE AGREEMENT

THIS IS A LEGALLY BINDING AGREEMENT. PLEASE READ IT CAREFULLY. BY CLICKING "I AGREE TO THE LICENSE TERMS AND CONDITIONS" OR INSTALLING CYSIV SENSOR, YOU AGREE TO THESE TERMS AND CONDITIONS.YOU ARE EITHER:

- Covered under this agreement by your company or service provider having already executed the "Cysiv Master Services Agreement" or "Cysiv Beta License Agreement" in which case you may ignore the rest of this EULA and simply click "Agree" or;
- For all other users you, agree to the terms in this End User License Agreement.

IF YOU DO NOT AGREE WITH THESE TERMS AND CONDITIONS, YOU MUST NOT USE THE CYSIV SENSOR.

1. INTELLECTUAL PROPERTY OWNERSHIP RIGHTS.

Title to the Software, Documentation, Updates and all patents, copyrights, trade secrets and other worldwide proprietary and intellectual property rights in or related thereto are and will remain the exclusive property of Cysiv and its licensors. End User may not remove any titles, trademarks or trade names, copyright notices, legends, or other proprietary markings in or on the Software, or Documentation and will not acquire any rights in the Software or Documentation, except the limited license specified in this Agreement. Cysiv owns all rights in any copy, translation, modification, adaptation or Derivative Works of the Software, including any improvement or development thereof. Cysiv retains all rights not expressly granted to End User in this End User License Agreement.

2. LICENSE GRANT AND FEES; HARDWARE

- 2.1 Software License. End User is granted a non-exclusive, non-transferable, non-assignable, non-sublicensable, restricted license during the term set forth in the Service Order, to use the Software offered as a Service. The Software and Documentation may not be distributed to any third parties. The license granted herein is subject to the specific restrictions and limitations set forth herein, and/or any additional licensing restrictions and limitations specified in the Master Services Agreement and Documentation, or by notification and/or policy change posted at www.Cysiv.com.
- 2.2 End User may use the Software for internal business purposes only in relation to its own computer systems and any computer systems or facilities owned or managed exclusively by or for End User. End User may not use the Software for providing hosted or service bureau services to the general public or any third-party entities.
- 2.3 Restrictions on Use. End User shall not (i) allow third parties or develop methods for third parties to use the Software; (ii) sell, rent, lease, use collectively, record, license, sublicense, share, distribute, publicly communicate, transfer or exploit in any other manner the Software or Documentation, unless otherwise expressly provided for in this Agreement; (iii) except as provided by applicable law, decompile, disassemble, or reverse engineer the Software, in whole or in part, and End User shall not attempt to obtain in any other manner



any Software source code, and shall not carry out any action to the detriment of Cysiv's intellectual property rights or those of its suppliers; (iv) make copies, execute, publish, or reproduce Software or Documentation, unless expressly authorized in this Exhibit (and all copies must maintain Cysiv's copyright notices); (v) develop any Derivative Works or any type of software program based on Software, the Documentation, or any other Confidential Information of Cysiv; (vi) make available, reveal, disclose, offer, or allow the use of Software without the prior written consent of Cysiv; (vii) alter or modify the Software without the prior written consent of Cysiv; (vii) alter or modify the Software without the prior written consent of Cysiv; (viii) reject, avoid, elude, remove, deactivate, or evade, in any way, any protection mechanism of the Software, including without limitation any mechanism used to restrict or control Software functions; (ix) provide or offer access to any third parties to any restricted online access keys or authentication passwords provided by Cysiv for accessing Software; or (x) disclose to any third party any benchmarking or comparative study involving the Software or Documentation.

- 3. INCORPORATION OF MASTER SERVICES AGREEMENT, BETA LICENSE AGREEMENT AND PRIVACY POLICY.
 - 3.1 Customer End Users. Each Customer End User agrees that the Master Services Agreement and Beta License Agreement is hereby incorporated herein by this reference and, in addition to this End User License Agreement, govern the use of the Cysiv Software, Services and Solutions.
 - 3.2 Conflicts. If a conflict arises between this End User License Agreement, Beta License Agreement and the Master Services Agreement, the Master Services Agreement shall control.

CYSIV SPECIFICALLY DISCLAIMS AND EXCLUDES ANY WARRANTY, GUARANTEE, AND/OR LIABILITY TO CUSTOMER OF ANY KIND OR NATURE (WHETHER STATUTORY, EXPRESS, OR IMPLIED) WITH RESPECT TO THE SOFTWARE, SERVICES, SOLUTIONS AND DOCUMENTATION (AS DEFINED ABOVE)., AND DELIVERABLES, INCLUDING ANY WARRANTY, GUARANTEE, OR AND/OR LIABILITY REGARDING MERCHANTABILITY, FITNESS FOR A PARTICULAR OR NON-INFRINGEMENT OF THIRD PARTY INTELLECTUAL PROPERTY RIGHTS.
 - 4.2 Assurances. CYSIV DISCLAIMS AND CANNOT, AND DOES NOT HEREIN, PROVIDE ANY ASSURANCE, WARRANTY, OR GUARANTEE OF ANY KIND THAT THE RECEIPT, USE, OR IMPLEMENTATION OF ANY SOFTWARE, SERVICES, DELIVERABLES, OR INSTRUCTIONS IN CONNECTION WITH THIS END USER LICENSE AGREEMENT OR ANY RESULTS ACTUALLY OR PURPORTEDLY RELATED THERETO WILL ASSURE OR GUARANTEE, COMPLETE, OR PERFECT PROTECTION FROM AND AGAINST OR DETECTION, IDENTIFICATION, BLOCKING, REMOVAL, REMEDIATION, OR RESOLUTION OF ANY OR ALL VULNERABILITIES, SECURITY ATTACKS, INTRUSIONS, INCIDENTS, BREACHES, OR THREATS TO CUSTOMER OR TO NETWORKS, SYSTEMS, ASSETS, INFORMATION, AND/OR DATA OF CUSTOMER, CUSTOMER'S CLIENTS, OR ANY OTHER PARTIES, CUSTOMER, CUSTOMER'S CLIENTS, OR ANY OTHER PARTIES FREE FROM ANY OR ALL VULNERABILITIES (AS DEFINED ABOVE) OR SAFE FROM PRESENT OR FUTURE SECURITY ATTACKS, INTRUSIONS, INCIDENTS, BREACHES, OR THREATS.



- 4.3 CYSIV MAKES NO WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, WITH RESPECT TO THE SOFTWARE, SERVICES, SOLUTIONS AND DOCUMENTATION, INCLUDING BUT NOT LIMITED TO WARRANTIES OF QUALITY, PERFORMANCE, MERCHANTABILITY, FITNESS FOR ANY PARTICULAR PURPOSE, CONFORMITY TOANY REPRESENTATION OR DESCRIPTION, OR NON-INFRINGEMENT.
- 4.4 LIMITATION OF LIABILITY.

IN NO EVENT, WHETHER IN TORT, CONTRACT, OR OTHERWISE, SHALL CYSIV OR ITS LICENSORS, PARTNERS, OR SUPPLIERS BE LIABLE TO END USER OR ANY THIRD PARTIES UNDER THIS END USER LICENSE AGREEMENT FOR ANY INDIRECT, SPECIAL, INCIDENTAL, PUNITIVE, OR CONSEQUENTIAL DAMAGES, COSTS, LOSSES OR EXPENSE, (INCLUDING BUT NOT LIMITED TO LOST PROFITS, LOSS OR INTERRUPTION OF USE, LOSS OF DATA, DAMAGE TO NETWORKS, EQUIPMENT, OR HARDWARE, OR THE COST OF PROCUREMENT OF SUBSTITUTE GOODS OR TECHNOLOGY), OR ANY AMOUNTS IN EXCESS OF THE ORIGINAL PURCHASE PRICE OF THE SOFTWARE, PROFESSIONAL SERVICES OR OTHER AMOUNTS PAID UNDER A PERTINENT SALES ORDER FORM. THE FOREGOING LIMITATIONS SHALL APPLY TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW.

5. CONFIDENTIAL INFORMATION

- 5.1 "Confidential Information" of Cysiv Defined. "Confidential Information" includes: (a) the Software, Services, Solutions and Documentation; (b) any and all information disclosed by Cysiv, in whatever format, that is either identified as or would reasonably be understood to be confidential and/or proprietary, including but not limited to Cysiv's pricing, business plans, strategies, financial information, marketing information, marketing strategies and customer lists; (c) any notes, extracts, analyses or materials prepared by the receiving party which are copies of or derivative works of Confidential Information or from which Confidential Information can be inferred or otherwise understood; and (d) the terms and conditions of this End User License Agreement. "Confidential Information" does not include information that the End User can clearly establish by written evidence: (e) is or becomes known to the receiving party from a third party without an obligation to maintain its confidentiality; (f) is or becomes generally known to the public through no act or omission of the receiving party; or (g) is independently developed by the End User without the use of Confidential Information.
- 5.2 Non-Customer User's Obligations. The Non-Customer User will make no use of Confidential Information for any purpose except as expressly authorized in this Agreement. Except as expressly authorized in this End User License Agreement, the End User will not disclose Confidential Information to any third party and will protect and treat all Confidential Information with the same degree of care as it uses to protect its own confidential information of like importance, but in no event with less than reasonable care. In the event that the End User is required to disclose Confidential Information pursuant to law, the End User will notify Cysiv of the required disclosure with sufficient time for Cysiv to seek relief, will cooperate with Cysiv in taking appropriate protective measures, and will make such disclosure in a fashion that maximizes protection of the Confidential Information from further disclosure.
- 5.3 Destruction of Confidential Information. Upon the expiration or earlier termination of this End User License Agreement, each party will immediately terminate all use of and destroy all Confidential Information of the disclosing party and all copies thereof and, at the disclosing party's request, will certify in writing that it has destroyed the information.



6. TERM AND TERMINATION

This End User License Agreement and the licenses granted hereunder shall remain in effect for the period specified in any applicable Service Order Form or Beta License Agreement, unless earlier terminated as set forth herein. Cysiv may terminate this Agreement and the licenses granted hereunder, upon written notice for any material breach of this Agreement that End User fails to cure within thirty (30) days following written notice specifying such breach. Except as expressly provided herein, Sections 1, 2, 4, 5, 7, and 8 of this End User License Agreement shall survive termination.

7. INDEMNIFICATION

- 7.1 Cysiv shall indemnify and hold harmless End User and its officers, employees, agents and representatives and defend any action brought against same with respect to any third-party claim, demand or cause of action, including reasonable attorney's fees, to the extent that it isbased upon a claim that the Software infringes or violates any United States patents, copyrights, trade secrets, or other proprietary rights of a third-party.
- 7.2 End User may, at its own expense, assist in such defense if it so chooses, provided that Cysiv shall control such defense and all negotiations relating to the settlement of any such claim. EndUser shall promptly provide Cysiv with written notice of any claim which End User believes falls within the scope of this Section 6. In the event that the Software or any portion thereof is held to constitute an infringement and its use is enjoined, Cysiv may, at its sole option and expense,
 - modify the infringing Software so that it is non-infringing, (ii) procure for End User the right tocontinue to use the infringing Software, or (iii) replace said Software with suit-able, non- infringing software.
- 7.3 Notwithstanding the foregoing, Cysiv will have no obligation for any claims to the extent such claims result from (i) modifications or alterations of the Software made by or for End User or any other party that were not provided by Cysiv or authorized by Cysiv in writing; (ii) use outside the scope of the license granted hereunder, (iii) use of a superseded or previous version of the Software if infringement would have been avoided by the use of a newer version which Cysiv made available to End User, or (iv) use of the Software in combination with any other software, hardware or products not supplied by Cysiv. This indemnity obligation is subject to the limitation of liability and does not apply to any open source components of the Software.
- 8. GENERAL. The General provisions set forth in the Master Services Agreement are incorporated herein by reference.
