About the IoT Posture Assessment Library

The CounterACT IoT Posture Assessment Library is a Content Module that delivers a library of pre-defined login credentials that are used by the IoT Posture Assessment Engine to aid in determining the security risk of devices. These include:

- Factory default credentials for various devices, such as select IP cameras, routers, switches, and printers
- Commonly used credentials

Each login credential includes the following fields:

- Username and Password for devices communicating over Telnet and SSH
- Community String for devices communicating over SNMP

The CounterACT IoT Posture Assessment Engine uses these credentials to resolve the Credential Vulnerability property for factory default credentials and for commonly used credentials.

The library content is updated periodically:

- to increase the breadth of the devices for which factory default credentials are known
- to update the list of commonly used credentials

It is recommended to install the latest version of the content module containing the IoT Posture Assessment Library so that the most current credential vulnerabilities are assessed.

How It Works

The IoT Posture Assessment Engine provides a *Credential Vulnerability* property that attempts to log in to each connected device. The property uses the factory default credentials and the commonly used credentials provided by the IoT Posture Assessment Library. Display the Commonly Used Credentials

To view the commonly used credentials contained in the library:

- 1. Select **Options** from the CounterACT Console **Tools** menu, and select **IoT Posture Assessment Engine**.
- 2. Select the Commonly Used Credentials tab. A list of common credentials is displayed for:
 - Telnet/SSH Credentials: Username and Password
 - SNMP Credentials: Community String

3. To refresh the display after a new version of the IoT Posture Assessment Library was installed, select the **Refresh** button. The updated list is displayed.

CounterACT Software Requirements

This component requires the following CounterACT releases and other CounterACT components:

- CounterACT version 8.0.
- An active Maintenance Contract for CounterACT devices.
- Core Extensions Module version 1.0, including the IoT Posture Assessment Engine.

Install the Module

The content module containing the IoT Posture Assessment Library is included in the CounterACT version 8.0 installation. It is recommended to install the latest available version of the module so that the most current credential vulnerabilities are assessed.

To install the module:

- **1.** Navigate to one of the following ForeScout portals, depending on the licensing mode your deployment is using:
 - Product Updates Portal Per-Appliance Licensing Mode
 - <u>Customer Portal, Downloads Page</u> Centralized Licensing Mode

To find out which licensing mode your deployment is working with, see <u>Identifying Your Licensing Mode in the Console</u>.

- 2. Download the module .fpi file.
- **3.** Save the file to the machine where the CounterACT Console is installed.
- 4. Log into the CounterACT Console and select **Options** from the **Tools** menu.
- 5. Select Modules. The Modules pane opens.
- 6. Select Install. The Open dialog box opens.
- 7. Browse to and select the saved module .fpi file.
- 8. Select Install. The Installation wizard opens.
- **9.** Select **I agree to the License Agreement**, and select **Install**. The installation will not proceed if you do not agree to the license agreement.
- Make sure you have selected the correct module to install. The installation will begin immediately after selecting Install, and cannot be interrupted or canceled.
- In modules that contain more than one component, the installation proceeds automatically one component at a time.
- **10.**When the installation completes, select **Close** to close the wizard. The installed module is displayed in the Modules pane.

Identifying Your Licensing Mode in the Console

If your Enterprise Manager has a *ForeScout CounterACT See* license listed in the Console, your deployment is operating in Centralized Licensing Mode. If not, your deployment is operating in Per-Appliance Licensing Mode.

Select **Options** > **Licenses** to see whether you have a *ForeScout CounterACT See* license listed in the table.
