An active Maintenance Contract for CounterACT devices is required.

About This Plugin

The HPS Vulnerability DB (Host Property Scanner Vulnerability Database) makes vulnerability updates available to CounterACT soon after they are released from Microsoft. CounterACT pushes vulnerability update information provided in this update to Windows endpoints to resolve the **Microsoft Vulnerabilities** or **Microsoft Vulnerabilities Fine-tuned** properties.

SecureConnector is not required to download or work with HPS Vulnerability DB information on endpoints.

72080 72122	(In environments that have not yet installed Service Pack 2.3.3 or above) After upgrade, when users select vulnerabilities in the Microsoft Vulnerabilities property, the updated list of vulnerabilities may not be displayed in the dialog. Workaround Close the Console, and log in again to the Console.

How to Install

Perform the following steps to download this release and install it on the Console.

To install the plugin:

1. Navigate to the [Customer Support, Base Plugins](#) page and download the plugin `.fpi` file.
2. Save the file to the machine where the CounterACT Console is installed.
3. Log into the CounterACT Console and select **Options** from the **Tools** menu.
4. Select **Plugins**. The Plugins pane opens.
5. Select **Install**. The Open dialog box opens.
6. Browse to and select the saved plugin `.fpi` file.
7. Select **Install**.
8. An installation or upgrade information dialog box and a license agreement dialog box will open. Accept the license agreement to proceed.
9. Once the installation is complete, select **Close**. The plugin is listed in the Plugins pane.
