



## END USER LICENSE AGREEMENT

This End User License Agreement is entered into by and between ForeScout Technologies, Inc., a Delaware corporation, and each of its subsidiaries, including ForeScout Technologies BV (formerly SecurityMatters BV) and ForeScout Technologies Americas Inc. (formerly SecurityMatters Americas Inc.) ("**Licensor**") and the customer set forth on the Order ("**Licensee**") as of the date of the Order.

The following terms are defined below:

- a) "**Annual Software License**": means the right to use the Licensed Software on a yearly basis; such license includes the right to Maintenance, if any, as set forth on the Order.
- b) "**Documentation**": means any program documentation, user manuals, handbooks and other materials describing the use, design, installation, operation, maintenance, and/or functional and technical specifications of the Licensed Software, made available by the Licensor to the Licensee in electronic format;
- c) "**Error**": means the substantial failure to meet the functional or technical specifications as set forth in the Documentation of the Licensed Software. An Error shall only be deemed to exist if Licensee is able to demonstrate the Error and if it can be reproduced.
- d) "**Intellectual Property Rights**": mean any patent, copyright, word mark or pictorial mark, trade name, logos, designs, model right, design right, know-how, and all other intellectual property rights of Licensor or its suppliers/licensors.
- e) "**License Fee**": mean either the: (1) one-time fee for the Perpetual Software License or (2) the annually recurring fee for the Annual Software License, both payable to Licensor for use of the Licensed Software and Documentation.
- f) "**Licensed Software**": means the Perpetual Software License or the Annual Software License, including the object code version thereof, the Documentation and other supplemental materials as provided to Licensee by Licensor, including but not limited to any software security keys, modifications or additions relating thereto. The Licensed Software shall include any Updates and Upgrades of the Licensed Software that Licensee receives under Maintenance as set in the applicable Order. This License Agreement does not grant Licensee the right to any Updates and Upgrades of the Licensed Software unless Licensee has purchased Maintenance for the period when the Updates and Upgrades are made available.
- g) "**Maintenance**": means Level 1 and Level 2 services, which may include Updates and Upgrades of the Licensed Software, offered during Licensor's normal business hours are described in Licensor's Technical Support Policy, as set forth on <https://www.forescout.com/company/legal/security-matters-technical-support-policy/>.
- h) "**Offer**": means the applicable offer document issued by the Licensor that refers to this License Agreement, and that describes in greater detail Licensee's order-specific information, including quantity, pricing, and products and services.
- i) "**Order**": means the applicable ordering document, acceptable to Licensor, issued by Licensee in acceptance of the terms of the Offer and subject to this License Agreement.
- j) "**Perpetual Software License**": means the right to use the Licensed Software for an indefinite period of time – unless terminated pursuant to the terms of this License Agreement.
- k) "**System**": means the equipment, hardware (including systems software) on which the Licensed Software must be installed.
- l) "**Update**": means a bug fix, update, patch, module replacement or improved version of the whole or any part of the Licensed Software, provided as part of the Maintenance;
- m) "**Upgrade**": means a new version of the Licensed Software consisting of a major release to be implemented on the System as a result of a System update or change.

### 1. Grant of License

For payment of the applicable non-refundable license fees, Licensor grants solely to Licensee a non-transferable, non-sub-licensable and non-exclusive license to use the Licensed Software subject to the terms and conditions set forth in this License Agreement. If the Licensee is purchasing a Perpetual Software License, the term of the license will be perpetual, subject to the terms of this License Agreement. If the Licensee is purchasing an Annual Software License, the term of the license will be annual, subject to the terms of this License Agreement. Licensee shall have the right to use the Licensed Software on a designated System in accordance with the Documentation solely for its own internal use and benefit. For the avoidance of doubt, the use of the Licensed Software does not permit: (i) third parties, contractors (including without limitation outsourcing parties) to access or use the Licensed Software for Licensee's internal use and benefit without the prior written consent of Licensor and payment of an additional license fee, (ii) Licensee to use the Licensed Software on behalf of third parties, e.g. for services such as 'time-sharing', 'application service provision', 'software as a service' and 'outsourcing', and/or (iii) installation, use or access of the Licensed Software on, in or from hardware and software except the designated System provided by Licensor.

### 2. User Restrictions and Licensee Responsibilities

Licensee agrees not to, and shall not permit others to:

- a) Copy and distribute the Licensed Software, in whole or in part, without paying the applicable additional fees, except (i) for making a reasonable number of archival back-up copies for its internal use, or (ii) as expressly

authorized by Licensor in writing, or (iii) for making a reasonable number of copies of the Documentation for its internal use. Licensee shall reproduce and affix all copyright and other Intellectual Property Rights notices appearing in or on the Licensed Software in such copies thereof and shall under no circumstances remove or circumvent technical provisions intended to protect the Licensed Software.

- b) Copy and/or distribute the Licensed Software, in whole or in part to third parties.
- c) Install, access or use the Licensed Software on hardware and/or an (operating) system other than the hardware and (operating) system for which the Licensed Software was originally licensed to Licensee and other than provided by Licensor without prior written consent of Licensor.
- d) Assign, sell, rent, lease, lend, sublicense, outsource or otherwise transfer the Licensed Software to any third party, or authorize or appoint any third party to do so.
- e) Use the Licensed Software for 'timesharing', facilities management, outsourcing, hosting, 'application service provider' and 'software as a service'.
- f) Modify the Licensed Software or provide a third party or any person with the means to do so.
- g) Create derivative works, translate, disassemble, recompile or reverse engineer any Licensed Software or attempt to do so (except to the extent applicable law specially permits such activity).
- h) Alter, destroy, or otherwise remove any intellectual property notices or labels and technical provisions on or embedded within the Licensed Software or Documentation.
- i) Remove or relocate the Licensed Software to another location than the location where Licensor has given its consent without prior written consent of Licensor.
- j) Utilize or permit another party to utilize any software application program created, in whole or in part, utilizing any Licensed Software.
- k) Use the Licensed Software in a manner other than described in the Documentation or as specifically permitted in this License Agreement.

### 3. Documentation

Licensee will receive the Licensed Software one electronic copy of Licensor's standard Documentation free of additional charge. Licensee is entitled to make copies of the Documentation solely for internal use and without destroying or removing the copyright and intellectual property notices on or embedded in the Documentation. Licensee is not permitted to modify the Documentation or to assign, sell, lend, sublicense, or otherwise transfer the Documentation to third parties without prior written consent of Licensor.

### 4. Term of License

- a) This License Agreement and Licensee's license for the Licensed Software is either perpetual (Perpetual Software License) or yearly (Annual Software License) as provided in the Order.
- b) Licensor may terminate this License Agreement and Licensee's license to the Licensed Software immediately by giving Licensee written notice of termination in the event that either (i) Licensee breaches any term or condition of this License Agreement and Licensee has failed to remedy such breach within thirty (30) days after a written notice from Licensor to Licensee or (ii) Licensee is wound up or terminated, has a receiver appointed or enters into liquidation or bankruptcy or analogous process in Licensee's home country or enters into a change of control in Licensee's company. If Licensee becomes bankrupt or is liquidated, the right of use of the Licensed Software shall terminate.
- c) In case the Licensee has opted for the Annual Software License, the Annual Software License will automatically renew for a period of one (1) year upon the expiration of the license, unless either party provides written notice no later than two (2) months prior to expiry of the Annual Software License.
- d) In the event of any termination, Licensee will have no right to keep or use the Licensed Software or any copy of the Licensed Software for any purpose and Licensee shall destroy and erase all copies of such Licensed Software in its possession or control, and forward written certification to Licensor that all such copies of Licensed Software have been destroyed or erased. In the event of any termination of the License Agreement and Licensee's license, Licensor is under no circumstances obliged to pay Licensee any compensation in whatsoever form and/or to reimburse the paid license fees.

### 5. Maintenance

- a) Licensor's obligation to provide Maintenance will be set forth in the Order and in accordance with the Technical Support Policy.
- b) Licensor is not obliged to provide Maintenance with regards to a version of the Licensed Software that is not supported according to Licensor's Technical Support Policy.

### 6. Order

Upon execution by Customer, each Order is non-cancellable and non-refundable, except as provided in this License Agreement. Customer will pay each invoice within 30 days after the invoice date unless otherwise stated on the Offer. Any such purchase order submitted by Customer is for its internal purposes only, and Licensee rejects, and in the future is deemed to have rejected, any purchase order's terms to the extent they add to or conflict in any way with this License Agreement or the applicable Offer, and such additional or conflicting terms will have no effect. Any shipment under this License Agreement will be FOB Origin.

## 7. Audit

Upon request, Licensee shall immediately lend its full cooperation to any investigators to be conducted by or on behalf of Licensor in relation to Licensee's compliance with the agreed restrictions on use. At the first request of Licensor, Licensee shall promptly grant Licensor access to the System. Licensor shall maintain the confidentiality of all company information to be regarded as confidential that Licensor obtains from or while on the premises of Licensee within the context of the investigation, in so far this information does not relate to the use of the Licensed Software itself. In the event that any audit reveals an underpayment by Licensee of more than five percent (5%) of the amounts due Licensor in the period being audited, or that Licensee has breached any term of this License Agreement, then, in addition to any other remedies Licensor may have, Licensee will promptly pay to Licensor any underpayments and the cost of the audit.

## 8. Intellectual Property Rights

All Intellectual Property Rights to the Licensed Software or other materials such as analyses, designs, Documentation and other documentation, reports, quotations and related preliminary material developed or made available to Licensee on the basis of this License Agreement shall remain exclusively vested in Licensor or its licensors or suppliers. This License Agreement does not convey any intellectual property interest to Licensee with respect to the Licensed Software or Documentation other than the license specified herein.

## 9. Confidentiality and Privacy

- a) Licensee acknowledges that the Licensed Software is of a confidential nature and that this Licensed Software contains trade secrets of Licensor or its licensors or suppliers.
- b) The Licensed Software may contain features which may allow Licensee to collect personal data of employees or other individuals without notice to them. Licensee is solely responsible for, and assumes all liability with respect to, the collection or processing of all personal data. Licensee shall indemnify and hold Licensor harmless from and against any damages, claims, losses, settlements, attorney's fees, legal fees and court costs and other expenses related to any such activities or any claims in connection therewith.

## 10. No Warranty

Licensor does not warrant that the Licensed Software made available to Licensee will be fit for the actual and/or intended use by Licensee. Licensee accepts that the Licensed Software may not operate and function without interruptions, Errors or other defects or that not all Errors and defects may be fixed. Licensee specifically understands and accepts that the Licensed Software may not detect all network intrusions.

Licensor shall make every effort to fix Errors in the Licensed Software within a reasonable period of time if Licensor receives a detailed written notification of these Errors within a period of ninety (90) days following delivery of the Licensed Software ("**Warranty Period**"). Licensee's exclusive remedy and Licensor's entire liability, whether in contract, tort or otherwise, for failure to comply with the foregoing obligation, Licensor will, at its discretion, do one of the following: (x) use reasonable commercial efforts to correct the Error; (y) replace the Licensed Software at no additional charge; or (z) refund the license fee and terminate Licensee's license to the Licensed Software.

Licensor shall use commercially reasonable efforts to fix Errors free of charge during the Warranty Period, provided that Licensor shall not fix any Errors or other defects arising from or related to any of the following ("**Excluded Service**"):

- i. usage errors or the improper use of the Licensed Software, including errors that occur during the data input process or in the data itself;
- ii. changes to the Licensed Software other than those carried out by or on behalf of Licensor;
- iii. use of the Licensed Software contrary to the applicable conditions or contrary to the instructions in the Documentation or other instructions of Licensor;
- iv. changes to or errors, defects or shortcomings in the System or Licensed Software that are not included within the scope of the Maintenance to be carried out by Licensor;
- v. the use of an older version of the Licensed Software that is no longer maintained by Licensor;
- vi. the recovery of scrambled or lost data; or
- vii. other causes that are not attributable to Licensor.

Licensor shall be entitled to invoice the costs of fixing Errors at its standard rates for Excluded Services. Licensor shall not be obliged to fix Errors if Licensee has made changes to the Licensed Software, or has arranged for this to be carried out, without the written consent of Licensor.

The fixing of Errors shall take place at a location to be determined by Licensor. Licensor shall be entitled to install temporary solutions, workarounds or problem-avoiding restrictions in the Licensed Software at any time.

EXCEPT AS EXPRESSLY SET FORTH ABOVE, LICENSOR DISCLAIMS ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF TITLE, NONINFRINGEMENT, MERCHANTABILITY AND



FITNESS FOR A PARTICULAR PURPOSE (REGARDLESS OF ANY KNOWLEDGE OF LICENSEE'S PARTICULAR NEEDS) AND THOSE ARISING BY STATUTE OR OTHERWISE IN LAW OR FROM A COURSE OF DEALING OR USAGE OF TRADE.

**11. Indemnity third-party software claims**

Licensor shall defend Licensee against any legal claim from third parties based on the assertion that the Licensed Software infringes the patent, copyright, trademark or trade secret rights of the third party, provided that Licensee (i) promptly notifies Licensor in writing of such claim, (ii) does not make any admission as to liability or agree to any settlement or compromise the claim without Licensor's prior written consent; (iii) at Licensor's request, gives Licensor the sole power to conduct all negotiations and litigation, and to settle all litigation, arising from such claim; and (iv) provides Licensor with all available information and assistance as Licensor may reasonably require. In addition, Licensor shall indemnify and hold Licensee harmless from and against all damages, liabilities and losses finally adjudicated or settled in connection with such claim. This Article does not apply if any infringement arises from any addition or modification made to Licensed Software or combination of the Licensed Software with software or hardware not provided by Licensor (except to the extent that the claim is based on the Licensed Software alone), other than by or under the authority of Licensor. If the Licensed Software is held to infringe or is believed by Licensor to possibly infringe, Licensor shall have the option, at its expense, to (i) modify the Licensed Software to be non-infringing; or (ii) obtain for Licensee a license to continue using the Licensed Software. If Licensor determines it is not commercially reasonable to perform either of the above options, then Licensor may at its option elect to terminate the license for the Licensed Software and refund the fees paid to Licensor by Licensee for Perpetual Software Licenses on a five year amortization schedule from the date of the Order or refund the fees pre-paid to Licensor by Licensee for Annual Software Licenses for the remaining unused portion of the annual term. THIS SECTION STATES LICENSEE'S SOLE AND EXCLUSIVE REMEDY FOR INFRINGEMENT OR CLAIMS ALLEGING INFRINGEMENT.

**12. Limitation of Liability**

LICENSOR'S CUMULATIVE LIABILITY IN CONTRACT, TORT OR OTHERWISE ARISING OUT OF OR IN CONNECTION WITH THE LICENSED SOFTWARE, OR LICENSOR'S AGREEMENT WITH LICENSEE, SHALL NOT EXCEED THE LICENSE FEES PAID BY LICENSEE FOR THE LICENSED SOFTWARE IN THE TWELVE MONTHS PRECEDING THE EVENT GIVING RISE TO THE CLAIM. IN NO EVENT SHALL LICENSOR OR ITS DEVELOPERS, DIRECTORS, OFFICERS, EMPLOYEES, AFFILIATES OR SUPPLIERS BE LIABLE FOR SPECIAL, INDIRECT, EXEMPLARY, INCIDENTAL, PUNITIVE OR CONSEQUENTIAL DAMAGES (INCLUDING ANY DAMAGES RESULTING FROM LOSS OF USE, LOSS OF DATA, LOSS OF PROFITS, LOSS OF SAVINGS, LOSS OF BUSINESS OR OTHER ECONOMIC LOSS). THE FOREGOING LIMITATION SHALL APPLY REGARDLESS OF THE CAUSE OF ACTION UNDER WHICH DAMAGES ARE SOUGHT AND EVEN IF LICENSOR OR A REPRESENTATIVE OF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

**13. Miscellaneous**

Licensor and Licensee are not entitled to assign rights and obligations of this License Agreement to third parties without prior written consent of the other party. However, notwithstanding the foregoing, Licensor may assign this License Agreement in its entirety to (i) any affiliate of Licensor; (ii) any successor in interest to Licensor by way of merger or consolidation; or (iii) a purchaser of all or substantially all of the assets of Licensor, provided that the assignee agrees in writing to be bound by all of the terms and conditions of this License Agreement. This License Agreement shall be binding on and inure to the benefit of the successors and permitted assigns of the parties. This Agreement constitutes the entire agreement between Licensor and Licensee with respect to the subject matter hereof, and supersedes all prior agreements, understandings and negotiations, both written and oral, between the parties with respect to such subject matter. No waiver, amendment or modification of any provision of this Agreement shall be enforceable against a party unless it is in writing and signed by such party.

**14. Applicable Law and Dispute Resolution**

- a. This License Agreement and any ensuing agreement shall be governed by and construed in accordance with the laws of California. The UN Convention on Contracts for the International Sale of Goods will not apply.
- b. Any dispute between Licensor and Licensee arising from this License Agreement and/or any ensuing agreement shall be exclusively settled by the competent court of Santa Clara, California.
