Forescout Professional Services & Training Vouchers

Forescout Professional Services Vouchers and Training Vouchers (*FS-SVC-VOUCHER*) provide a flexible option for Forescout customers to purchase Forescout professional services and/or training services (collectively, the “Services”). Customers may buy vouchers for the applicable Services at the time of original purchase of Forescout products or as a separate, standalone purchase. For customers who have not finalized the details of the specific Services required for their original Forescout product implementation, vouchers offer customers the flexibility to budget for anticipated Services up front and later redeem those pre-purchased vouchers once the specific needs are defined. This option helps manage costs upfront and mitigates the need to allocate additional funds that may no longer be available after the product has been ordered. Vouchers can be used for any of the standard Forescout Services offerings listed below and must be used within one (1) calendar year from the date the applicable products are shipped, or for a virtual product, the date first made available electronically.

Available Professional Services and Training Courses

Customers may redeem vouchers for any of the Services listed below, or found at <https://www.Forescout.com/support>. Custom Services can also be purchased via a voucher, however, the Services must be scoped and documented in a statement of work (“SOW”) signed by both parties prior to delivery. Scheduling of Services delivery is subject to availability and Forescout’s standard policies. Certain international locations may be limited to remote Services only.

How Vouchers Work

- 1) Forescout recommends customers purchase vouchers incrementally based on their budgeted Services needs. If requested, Forescout’s Project Management Office (“PMO”) can assist with scoping for standard or customized Services packages.
- 2) Customer is invoiced for vouchers at the time of purchase and payment is due within 30 days.
- 3) When ready to redeem vouchers, customers contact the Forescout PMO team to arrange delivery of the applicable Services based on Forescout’s standard offerings, or for customized Services, to initiate a scoping review and SOW defining the requirements. Scoping review and planning typically take two to four weeks and involve Forescout’s PMO team and as well as the appropriate representatives from the customer’s IT, Engineering or Legal organizations.
- 4) Standard Services engagements are delivered in accordance with the relevant Forescout datasheet. Custom Services are provided in accordance with a fully executed SOW.

Availability

- Vouchers are available for purchase globally and can be used for Services listed below and can only be redeemed by Forescout end-user customers, whether purchased directly from Forescout or from Forescout authorized partners.

FS-PS-HC-03	Three consecutive days of on-site health check services for existing deployments, includes travel. Refer to the Health Check datasheet for details.	9,000
FS-PS-IMPL-01	One additional day of on-site Professional Services for initial implementations, includes 1 day of travel. Must be used only in conjunction with the FS-PS-IMPL-03 SKU, for a maximum of 10 days in total combined (on-site and remote). Refer to the Quick Start datasheet for details.	3,000
FS-PS-IMPL-03	Three consecutive days of on-site Professional Services for initial implementations, includes travel. Maximum quantity of one (1). Refer to the Initial Implementation datasheet for details.	9,000
FS-PS-IMPL-REMOTE-50	Half day of remote Professional Services for an initial implementation engagement. To be used in conjunction with FS-PS-IMPL-03 and FS-PS-IMPL-01 SKUs, for a maximum of 10 days total combined (on-site and remote). Refer to the Initial Implementation datasheet for details.	1,000
FS-PS-STAFFAUG-01	One day of on-site staff augmentation consultant services for existing deployments, includes 1 day of travel. Minimum 3 consecutive days must be scheduled for onsite engagements. May be sold in multiples up to 10 days. Refer to the Staff Augmentation (Professional Services Consultant) datasheet for details.	3,000
